



Finance Corner - November 1, 2020



Dear Supporter of Trinity's Ministry:

Despite the challenges our country has faced in 2020, your faithful giving in 2020 has made a real difference in our congregation's ability to share the Gospel:

 We purchased and installed a new suite of video equipment to improve our ability to live-stream our worship services;

• Due to a special gift, we've been able to significantly reduce the amount due on our operational debt and expect to pay off that loan by the end of 2021. Our only remaining indebtedness will then be the Education Center's mortgage. As of the end of September, we had an outstanding balance of \$175,301 in the operational debt loan, and \$3,414,135 outstanding on our mortgage loan;



Despite COVID, we all have so much to be thankful for. The pandemic has only increased the need for our city to hear the Good News of Jesus' love, and the only way Trinity can play our part is through your generous giving of time, talent and treasure.

On Saturday and Sunday, November 14th and 15th, we'll be returning the 2021 Commitment Cards which we mailed in late October. Ask God to guide your thoughts on what He would have you give in the coming year. Then write down your planned gift on the Commitment Card and bring it to church with you on November 14th or 15th or complete an <u>online pledge card</u>. 

Annual Congregational Assembly Meeting

Our Annual Congregational Assembly will be held on Sunday, November 15, 2020, at noon. Due to the social distancing requirements and other safety protocols associated with the coronavirus epidemic, this year's Assembly will be held virtually via Zoom with no in-person attendance.

The agenda for the Assembly is:

- Opening prayer
- Approval of the Congregational Assembly meeting minutes from November 2019 and July 2020
- Election for four open positions on the 2021 Governing Board and Elders
- Election of the 2021 Nominating Committee
- Presentation of the Governing Board report
- Ratification of the 2021 Ministry Spending Plan
- Adjournment



- Zoom credentials and a confirmation number they may use to attend the virtual meeting;
- A copy of the meeting minutes from the two previous Congregational Assemblies;
- Biographical information of each of the Governing Board and Elder candidates; and
- A copy of the proposed 2021 Ministry Financial Plan.

To join the virtual Congregational Assembly, **each voting member will need to use their own digital device** so each vote may be tallied individually. Voters may use a smartphone, tablet, iPad, laptop computer or desktop computer that has internet access. Devices that can install the "Zoom" application will be the easiest to operate.

Age: 43

Years Trinity Member: 13

Occupation: Executive and Communications Assistant, LINC Ministries

Summarize your prior or present involvement in the church:

We "found" Trinity through Pastor David Leeland's numerous visits to my husband's grandfather in the hospital in 2006. The deal was sealed after an invitation to a Trinity Sunday Barbecue on the soccer fields where we were embraced by members and Pastor Dorn. (The food was good,



Led by Pastor Donald Black - 7:30 a.m.



- Uncertainty about the future



Chrismons - Advent Sermon Series

Monograms are two or more letters that are combined to form a symbol or logo. They are used by countries, companies, and colleges. Your favorite sports team likely has a monogram. People use them to personalize stationary, luggage, clothing and even keeping track of their underwear. The earliest known examples of monograms can be found on coins dating back to 350BC. Over the centuries, monograms of the name of Jesus Christ have been used as Christian symbols and are called Christograms.

In 1957, Frances Kipps Spencer, a member of Ascension Lutheran Church in Danville, VA, came across drawings of Christograms. She saw how they could be used to tell the story of the Gospel at Christmas time which led her to the idea of using them to decorate a Christmas tree. Frances called the symbols she put on the tree "Chrismons" a combination of "CHRISt" and "MONogram."

Using Chrismons to decorate Christmas trees quickly became popular in congregations across the country. They are traditionally colored white and gold (the liturgical colors for Christmas symbolizing Jesus' purity and perfection). Chrismons can be made from nearly anything but mostly commonly include the use of styrofoam and beads.



Many years ago the ladies of Trinity Downtown made Chrismons to decorate the trees in the Sanctuary. However, in the recent past these decorations have been put on a smaller tree in the Foyer. This year the Chrismons will be used again in the Sanctuary and these decorations will be the focus of the Advent Sermon Series. A team from the congregation is also making Chrismon kits so that you can make a Chrismon for your tree at home. The kits will be available beginning in mid-November and can be delivered to your home if you are unable to pick one up at church.

An explanation of a Chrismon will be included with each Sunday message during Advent. In addition there will be a brief daily devotional that you can watch on demand online about one of the Chrismons. These daily devotionals will replace the in-person mid-week Advent services typically held at Trinity Downtown on Wednesdays. While this may be an unusual year, the Worship Team hopes that this Advent series will be very meaningful and lead to a joyful celebration of Christ's birth.



Christmas Worship — Make Your Reservation Beginning December 1st

On December 24th this year there will be three services at 3:00, 5:00, and 7:00 p.m. in order accommodate members guests who want to and worship in person on Christmas Eve. The decision to add a third service was based on the results of a recent survey of the congregation (thanks to all who took a few minutes to complete the Christmas survey). Due to COVID safety protocols seating will be limited in the Sanctuary at each service so RSVPs will be very important. The Christmas survey indicated what has been



historically true at Trinity Downtown, the most popular worship time is 5:00 p.m. If you have flexibility on December 24th to worship at another time, please choose 3:00 or 7:00 p.m. For those who are not comfortable attending in-person on Christmas Eve, streaming and on demand options will be available. The Christmas Eve service will follow the traditional format of Lessons & Carols and will include a candle lighting ceremony. However, there will not be a pageant with live animals this year.

On Christmas Day, December 25th there will be one service at 9:00 a.m. that will be both in-person and live streamed with on demand available too. This Festival Service will be in a similar format as previous years with special music and beloved carols.

You will be able to make reservations for Christmas Eve/Day worship beginning on December 1st. Once the Sanctuary capacity limit has been reached those attempting to make a reservation will be instructed to select another worship time. Please be considerate of others by reserving only as many seats as are needed. If you are unable to attend at the time selected, please notify the church office as soon as possible so that the seating is available for others. Reserved seating will be released 10 minutes before the start of worship, so don't be late.

While the Governing Board and Administrative Staff are regularly evaluating the level of protocols required to protect those who attend worship in person, it is anticipated that reservations, temperature checks, health questions, and masks will still be required at Christmas time. Homeless Christmas Lunch Adapting to COVID Restrictions

Trinity Downtown has traditionally provided a sit-down Christmas meal for those in our community who are suffering from being homeless. Typically serving over 125 individuals, we provide a restaurant-style "home cooked" meal with all the trimmings. Congregants prepared shoe boxes filled with socks, toiletries and other useful items that were distributed to the participants, and Christmas carols were sung while volunteers served the food to each guest.



Unfortunately, COVID-related concerns will mean that we must change the format of this great tradition for just this year. For 2020, we're planning on providing:

- A nice boxed meal from a commercial provider that we can distribute in a socially-distanced manner (similar to the method we use to distribute sack lunches);
- A \$25 gift card the recipient may use to purchase useful items but cannot be converted into cash.

We estimate the cost of this package for each individual will be \$45.00.

Greetings from Westfield House, Cambridge!

Yes, you read that, correctly! I am now in the UK and out of quarantine. Classes have begun, though they have all been online so far. In some respects, a lot has happened since my last update. In other respects, not much has happened because I've done a lot of sitting in front of my laptop!

Stephanie and I have been very blessed through this whole process by the generous support of our families – letting us stay in their houses, sharing their food with us, giving us their time, and loving us. We had a relatively easy time getting through the flight, the ride from London to Cambridge, and the stay in self-isolation (that's what they call quarantine over here). We're still adapting to the very different approach to classes, though.

Whereas American universities are heavily focused on lectures, the British system has a much smaller focus on lectures. Instead, they focus on small group interactions called 'supervisions.' Although it sounded

a bit like micromanaging to me at first, I now appreciate the approach more. The learning is much more open-ended here and these small group sessions allow a more personal interaction with a tutor – much more than a grad student who is earning some money on the side. These tutors are often teachers in their own right and offer detailed analysis of each student's writing.

That's a very good thing because we're almost exclusively assessed based on our writing. In other words, we don't get quizzes or multiple-choice tests at the end of our courses. No, we write essays. Even the courses which are listed as being assessed 'by exam' are still writing exams. The answers we write are just a bit shorter, apparently.

In any case, it will be interesting to see how these supervisions go over the next several months. We were initially overwhelmed by the amount of reading that was posted for us to go through for each class. We found out that it is not expected that we read everything. In fact, it seems that the overabundance of potential books, articles, and excerpts to read is to facilitate each student being able to pursue their own particular area of interest in the subject. For instance, out of eight readings posted for one lecture, I may only read one. And I may not even read the entire work. We are slowly learning to be selective in our reading.

In terms of classes, it is probably a bit too early to share too much of what we've learned. As we go through our lectures and readings, I get various impressions. In some cases, the classes seem very similar to classes I've already had at the seminary. So, that seems a bit disappointing. But I expect that as we get farther into the term, there will be more depth. Plus, many of the classes are heavily based on the Anglican viewpoint since they are the largest partner in the Theological Federation here. Westfield House is a very new member of the Federation, so most of the professors have been quite unfamiliar with Confessional Lutheran doctrine and practice. This allows us to get some insight into other traditions and perhaps pass on some of our own prior knowledge.

In other cases, we've felt in over our heads with the philosophical content. Stephanie dove into Freud while I read some more contemporary philosophers. Those were different classes, but we were both bewildered by the language these intellectuals use. I am simultaneously fascinated and repulsed by these philosophical writings. My background in engineering makes me scratch my head at many of the questions they ask and the approaches they take to try to find truth. My training in the Christian Church makes me think that they are just blind to the truth that is right in front of them in the Church and Scripture. But I also want to make sure that I can take whatever is valuable from these thinkers through the ages. I expect my own reasoning and thinking will be sharpened as a result. At least, I sure hope they will!

Aside from classes, Stephanie and I have been able to take a couple of walks into town. We are staying toward the outer ends of Cambridge, so we have to walk about ten minutes to get to the River Cam and cross over into the more historic area. Unfortunately, the colleges are closed except to their own students right now due to COVID restrictions. However, we did find out that we are able to book appointments to visit the chapels of certain colleges. That will be a goal for us over the next few months. Hopefully, the situation will get better and restrictions will ease up in the new year, allowing the colleges to open and restart Evensong services so that we can attend some of those.

In the meantime, we continue to adjust to this new, temporary phase of life, trying to make the most of our time here while also being diligent in our reading and writing. We are meeting new people and slowly getting to meet some of our classmates face-to-face. My first supervision is even in person! I may even regain a consistent sense of which day it is...



We enjoyed a traditional cream tea with house-made scones with our Westfield House principal and fellow DTM students after a casual tour of the town.

Until next month, I pray that you are all keeping safe and healthy.

Enjoy your socially distanced Reformation celebrations, All Saints commemorations, and possibly even Thanksgiving celebrations if I don't write before then! We have a couple of trips scheduled with our fellow exchange students over the next month, so there should be a few pictures.
